
Dick Slusser served as Secretary from then until October 21, 1992, when the charter document was returned to T.S.A. headquarters in Wheaton. Simultaneously, a charter was issued for the T.S. in Denver Study Center with Judith Lorraine as Secretary.

During the interval stated, a widening divergence of doctrinal loyalty occured. A new study center member, Al Skrobisch, offered to conduct study sessions on the three volume set, *Talks on the Path of Occcultism*, by C.W. Leadbeater and Annie Besant. Concurrently, the Secretary offered studies in *The Mahatma Letters to A.P. Sinnett*.





The study center will be a place where people can come together, be interested in each other and Theosophy. We will be able to share ideas and insights however diverse our backgrounds and interests and will welcome all who are seeking the truth.

The benefits of an official study center are several. Departments at Headquarters send helpful materials. Liberal discounts are allowed on the purchase of books from the Theosophical Publishing House. Also the group may receive visits from national or international representatives of the Society who will consult with the members about any problems they may have and give lectures for the group.

People do not have to join the National Society to attend the meetings. But, for people interested in memberships there are three types of memberships:

- Member of a branch(lodge): This is a more structured group than a study center and may vary on extensive activities, including a regular program for the public.
   Seven members are required before a branch can be formed.
- 2. Member-at-large: Affiliated directly with Headquarters and not attached

to any local group. A member-at-large is eligible to attend meetings of any branch or study center subject to the rules of the local group. How ever, he may not vote in its election or other business transactions.

- 3, Study center member: Study center members pay the same amount of dues as branch members.
- 3. Various people will be on vacation, we discussed not having a meeting in August but will decide one way or the other at the July meeting.
- 4. We will be deciding a name for our group at July's meeting. These names have been suggested and we would welcome any others:


- (a) what Theosophy means to you in your personal life

NEWS: WE ARE NOW "THE HIGH COUNTRY THEOSOPHICAL STUDY CENTER"

As can you see by the heading, we are now "The High Country Theosophical Study Center", having received our charter from Olcott headquarters, dated August 11, 1986. Our members are Dick Slusser (Secretary), Beverley Noia, Terry Todd, Marty Lyman and Jinny Adams. The first *four* are the founding members, Jinny having joined the T.S. at the time of our founding.

Your secretary has been busy working to promote Theosophy locally.

Public radio stations KGNU and KCFR have been asked to consider airing the QUEST radio program series with the object of attracting potential new members to our group.

The Boulder County Hospice has been offered access to C.W. Leadbeater's excellent pamphlet for the bereaved - "To Those Who Mourn", which is available from T.P.H. under a Kern Foundation grant for 2.5c each.

A Radio Shack 1000-SX computer is being Purchased which will give us word-processing and 'Letter-quality' Printer facility and later possibly a computer link-up with other Theosophical and similarly motivated groups via electronic mail, which should be a great asset in networking efforts.

Speaking of Networking efforts, your secretary has written to T.O.S. and Plenty U.S.A. requesting that they reciprocally exchange their publications. Also contacted was the Southern Calif. Federation of Theosophical Lodges - we will be receiving their Newsletter. They are working to unite the efforts of various Theosophical organizations and are also a networking center.

In expectation of having future meetings open to the public as a result of outreach efforts, we are looking for a public meeting place. Terry, Marty and Dick are checking on potential locations in Lafayette, Denver and Boulder. So far, the Public Libraries seem most attractive. In Denver, small rooms accommodating up to 20 are available free and have access to VCR and Movie equipment at a nominal charge.

We understand that there are some who have attended our meetings who support our efforts and wish to be kept informed on our progress altho they are not able to attend regular meetings due to other priorities. At our last meeting we discussed this and the cost of producing and mailing this newsletter and we all! agreed to contribute to its cost. TOPICS:BEVERLEY WILL PRESENT A BRIEF INTRODUCTION TO A STUDY OF THE MASTERS, who were the real founders of the Theosophical movement.

#### **NEWS**

Of particular interest in studying Their work and teachings is learning how we can apply these principles to the problematical situations in our daily lives in order to put into living practice the principle of world brotherhood.

Other aspects of the study of the Masters may also be of interest and are open to consideration as potential areas of study; such as:

Advice given by Them to individual aspirants,

Their work and responsibilities,

Their view of History, Science and Religion from the Occult viewpoint, etc.

Dick has been negotiating with "Learning Unlimited" (formerly Denver Free University), exploring the possibility of offering a public course in elementary Theosophy. L.U. has accepted the proposal and Dick has accordingly reduced his spring semester course load at Metro State University in order to have time available to prepare and teach the class.

The course will begin by addressing the pressing concerns of everyday life -: The arms race, the environment, terrorism ... and proceed to explore the more fundamental questions of human existence such as:

If answers exist, where are they to be found: in Science, Philosophy or Religion?

At this point the Theosophical world view will be explored, beginning with a short overview of the fundamental teachings of the principal world religions to show their underlying unity.

A brief history of the founding of the Theosophical movement will also be covered. Other aspects of the Theosophical world view will be considered:

The unity of all of the manifested universe as aspects of the One Life in evolution,

The twin laws of Karma and Reincarnation and the Law of Cycles.

It is hoped that by means of this introductory offering that potential members and workers for Theosophy can be attracted to our Study Center.

It is the experience of your Secretary that the average educated adult has never heard of the Theosophical movement, a movement which was intended by its Occult founders to "arrest the attention of the finest minds" and "to be the cornerstone of the future religion of humanity."

For a movement over 110 years old, having such lofty objectives and altruistic motives, it would appear that Theosophy deserves a more prominent shelf in the supermarket of ideas.

### TOPICS:

We shall continue our study and discussion of the Masters and Their work, using as source material a 32 page Xeroxed handout, provided at the last meeting.

The handout includes material from "The Masters and the Path", "Old Diary Leaves", "The Mahatma Letters," and "Letters from the Masters of Wisdom Series I", and may suggest topics for further study and discussion on the topic.

At the November meeting, Beverley Noia gave us her intuitive level approach to using the wisdom of the Masters for personal guidance, pointing out that H.P. Blav atsky has said that Theosophy can truly be understood only by an intuitive approach.

We were instructed to write down four "private questions" to be pondered upon, after which cards were passed out containing quotes from the Masters. Each per son also contributed a favorite spiritual quote or maxim.

Each then kept two cards having the most meaningful quotes and discarded the rest. A book of quotes of the Masters was also passed around, with the instruction to meditate upon our questions and open the book at random for a 'relevant' quote. This procedure is similar, Beverley said, to consulting the I Ching in which a seem ingly random choice is made to select a guidance quote or aphorism. The guidance I personally received to my problems was useful and encouraging.

The Theosophical course being offered thru Learning Unlimited is scheduled to run for seven weekly sessions of 1 1/2 hours and will be offered concurrently in Denver and Boulder. The course; "The Search for Truth, a Theosophical Quest", will be offered in Denver on Monday evenings at 7:00 pm beginning January 19, 1987. The Boulder section will be offered on Thursday evenings at 7:30 pm beginning on January 22, 1987.

The request to the department of education at Olcott for permission to use the Quest Radio series of program tapes has been approved and the tapes are being reviewed for their relevance to the course outline. It is anticipated that most of the series will be used. Presently it is planned to make use of them as pre - class study material to stimulate questions, to set the topic keynote and provide a point of departure for class discussion and study.

Bill Nicholson, at the Department of Education, has also put us in touch with Mrs. Diana Chapotin, for the purpose of enlisting her aid and advice in the preparation of the course content. Diana teaches Theosophy at Happy Valley School at Ojai, California nearby to Krotona Institute and presently offers private education from the theosophical viewpoint at grade levels 9 thru 12. A letter requesting her advice has been sent.

Bill has also informed me that Haydee Garcia, of the Theosophical Research study center in Miami is offerimg a Theosophical course in Spanish thru the 'continuing learning' section of the university of Miami and has also asked for help. Since Marty Lyman and I (Dick Slusser) plan to spend the Christmas holidays near Miami, we will plan to get in touch with her in order to exchange ideas and resources and perhaps visit the Miami Lodge while in Florida.

By the time this newsletter reaches you, the new Learning Unlimited catalog should be available. All those interested will be welcome in the class. Learning Unlimited is located at the Capitol Hill Community Center, 1290 Williams St., Denver and can be reached at 393-6706.
